## PACOM'S BULLETIN

Message from the President and the first Vice President - Looking Ahead to the Future

Dear PACOM Members and Friends,

I hope this message finds you well as we approach our first General Meeting of 2024. It's been a while since our last communication, but I am excited to reconnect with you all and provide some updates on our progress. First and foremost, I'd like to extend my warmest New Year greetings to each of you. I trust that you have had the opportunity to review the bulletins we've been sending out since last summer, ensuring you are up to date with all the latest news and developments.

Despite some challenges, we remain committed to maintaining a positive outlook and focusing on the success of our project. Following the 2022 election, we've noticed differing agendas among certain members. We remain open to listening to all perspectives and hope to foster unity within our community. We heard some complaints, but nobody ever suggested a solution in writing. We are trying to keep everything in order, and we are very hopeful that we succeed.

Just in the last few days, we have had tremendous success. We met with the neighborhood representatives in the Benevolent Police Association, who accepted our plans to build the 8-story building, as manifested in the numerous Miami River Commission meetings. Thanks to that, we are heading toward a final meeting with the City Commissioners to obtain approval for our Polonia Center's new zoning designation. Also, Mr. Lech Walesa, a former President of the Republic of Poland, was passing through Miami and met with us on our lot. He expressed his support and appreciation of our project.

My dear friends, we are getting there. We are just about to obtain all the necessary permits to start building. Hopefully, our Executive Building Committee will have a complete list of possible developers for us to choose the best party to build our Center. You can submit your proposal if you have any suggestions or know a developer; there is still time for that.

Throughout the past year, we've held numerous Board of Directors meetings, both virtually and in person, where we've discussed various project aspects and the overall well-being of PACOM.

Some key highlights include:

- Establishment of the Executive Building Committee, comprising Club members not on the Board, ensuring impartial decision-making in selecting a developer for our Polonia Center Project. Committee members: Mr. Zbigniew Klonowski, Mr. Zbigniew Jarosz, Mr. John Roland, and Mr. Daniel Olech, who is the chairman of the committee.
- Ongoing efforts to secure a loan to address our financial obligations, including debts owed to the Polish National Alliance, amounting to over \$200,000, hindering progress on our project. We must pay our debt to the Polish National Alliance in 2024.
- Appointing Mr.Buck as PACOM advisor and accountant.

By hearing some complaints right now, why didn't you come up with some suggestions back then? It has been a whole year since we sought your constructive advice or advisable criticism. If you were against the loan, why didn't you suggest an alternative option? We need something more than just words. We are in debt, and we need to pay it back. I would like to highlight that our loan should be sufficient enough to pay our debt and have some money to continue operating without any disturbance.

As we prepare for upcoming elections, I'd like to emphasize the importance of addressing the crucial following aspects:

- 1) Updating our membership list: As per our Constitution, we urge all members to confirm their current membership status to ensure eligibility for voting rights. Mr. Turski, who was appointed the membership committee chairman after reaching out to all members, has hardly received any feedback. We kindly ask everyone to confirm their membership either through email. If you wish to vote, you must pay your dues for 2024, which is \$100. As you are all aware, according to our Constitution, only members who are at least members for 6 months and in good standing can vote. The membership list must be completed by March 7th, 2024.
- 2) Approval of the revised PACOM Constitution: As of Summer 2023, Mr. Kwasniak and Mr. Les Surowiec have undertaken the task of updating our Constitution. We understand that the Board of Directors have already provided their comments. All members must review and provide feedback within two weeks of getting the final draft. The revised Constitution must obtain undivided members' approval by March 15th, 2024, at the latest.

3) The date of the Annual Meeting and Election needs to be determined based on the time of the approval of the Amended Constitution. Any eligible person who desires to be a candidate for a position on the Board of Directors must give written notice of their intention to seek such a position no later than forty (40) days prior to the scheduled Election, together with a one-page/one-sided information sheet describing their background, education, and qualifications. The Nominating Committee of five (5) or more members shall screen all possible candidates and make their recommendations prior to when the ballot is printed. Before the Annual Meeting and Election, the members will receive a Second Notice with a package including a Ballot that shall list the names of the candidates. The President will select the Nomination Committee from individuals willing to participate.

When I was elected President, which I consider a big honor, knowing of my various obligations and that I may not be accessible daily, I nominated Mr. Schindler, the first PACOM Vice President, to represent me in my absence. Because of this nomination, Mr. Schindler is the only person besides me who can send out the agendas for the meeting and represent PACOM in official matters.

Please be aware of it, and have no other members preparing agendas without consulting it with the President or Vice President.

We, as your elected leaders, will do everything in our power to see the success of this project. I believe all the members would like to see the Polonia Center built shortly. Please, we do not have space for negativity. If you are unhappy and don't want to agree, we won't be forcing you to stay with us; you can always tend us your resignation.

Thank you for your attention to these matters, and I look forward to our continued collaboration and progress in the year ahead.
